2 Relevant policies and guidance

- 2.1.1 The Davenport Green to Ardwick area lies mostly within the administrative area of Manchester City Council (MCC) with Trafford Metropolitan Borough Council (TMBC), Oldham Metropolitan Borough Council (OMBC), Tameside Metropolitan Borough Council (TaMBC) and Stockport Metropolitan Borough Council (SMBC) lying at the edges of the area.

2.2 Manchester City Council

- 2.2.1 The Core Strategy, 2012 – 2027², for MCC sets out the long-term strategic policies for Manchester’s future development and will form the framework that planning applications will be assessed against up to 2027.
- 2.2.2 Policy EN16, air quality, states that MCC will seek to improve the air quality within Manchester, particularly within the AQMAs, located along Manchester’s principal traffic routes and at Manchester Airport. It states, ‘Developers will be expected to take measures to minimise and mitigate the local impact of emissions from traffic generated by the development, as well as emissions created by the use of the development itself, including from combined heat and power and biomass plant. When assessing the appropriateness of locations for new development the Council will consider the impacts on air quality, alongside other plan objectives. This includes cumulative impacts, particularly in AQMAs.’
- 2.2.3 Policy DM1, Development Management, states that all development should have regard for ‘...effects on amenity, including privacy, light, noise, vibration, air quality, odours, litter, vermin, birds, road safety and traffic generation....’

2.3 Trafford Metropolitan Borough Council

- 2.3.1 The Local Plan for TMBC³ sets out an overarching strategy and development principles for Trafford to guide development until at least 2026.
- 2.3.2 Policy L5.15 (Climate Change – Pollution) states, ‘Development that has the potential to cause adverse pollution (of air, light, water, ground), noise or vibration will not be permitted unless it can be demonstrated that adequate mitigation measures can be put in place.’
- 2.3.3 Policy L5.16 (Climate Change – Pollution) states, ‘Within the Borough’s Air Quality Management Zones developers will be required to adopt measures identified in the Greater

Manchester Air Quality Action Plan, to ensure that their development would not have an adverse impact on the air quality.'

- 2.3.4 Policy R3 (Green Infrastructure) outlines measures that TMBC will implement to development an integrated network or green infrastructure, which will bring about reductions in air pollution.
- 2.3.5 The TMBC draft Local Plan⁴ was approved for public consultation on 14 December 2020. Policy EP3: Air Quality provides a range of measures aimed at improving air quality within Trafford, including '...measures to minimise air pollution at the design stage and incorporate best practice in the design, construction and operation of the development...' and '...green infrastructure in the design of the development...' The Plan will supersede the existing Plan and is due for adoption by TMBC in 2023.

2.4 Tameside Metropolitan Borough Council

- 2.4.1 Tameside Council is currently in the process of preparing its local plan that will guide future development in the Borough. Until the new local plan is produced, the Unitary Development Plan⁵ (UDP), adopted in 2004, will still be used to make planning decisions.
- 2.4.2 Policy T14 Transport Assessment states, '...applicants will be expected to supply an air quality impact assessment alongside a Transport Assessment, so that the effect of the traffic generation on any Air Quality Management Area that may be declared can be considered.'
- 2.4.3 Policy MW14 Air Quality states, '...when developments are proposed which could have a significant impact on local air quality, the Council will consider the extent to which the development may affect the target levels in any Air Quality Management Areas which are declared or the requirements of related action plans, and weigh this against other material considerations before granting planning permission. When developments are proposed within areas where air quality is likely to exceed the objectives set in the National Air Quality Strategy, the Council will consider the extent to which occupiers could be exposed to health risks from levels of air pollution in excess of national targets, taking into account the effect of action plans introduced to reduce such exceedances, and will weigh this against other material planning considerations before granting planning permission.'

2.5 Oldham Metropolitan Borough Council

- 2.5.1 Oldham Council's Development Plan Document Joint Core Strategy and Development Management Policies⁶ sets out the long-term vision and objectives for the borough until 2026.
- 2.5.2 Policy 9 on Local Environmental Quality and Amenity states, 'The Council will protect and improve local environmental quality and amenity by ensuring development: ...does not have an unacceptable impact on the environment or human health caused by air quality, odour, noise, vibration or light pollution; and ...does not result in unacceptable level of pollutants or exposure of people in the locality or wider area. Developments identified in the Air Quality Action Plan will required an air quality assessment...'

2.6 Stockport Metropolitan Borough Council

- 2.6.1 The Core Strategy for Stockport provides the overall spatial strategy for the Local Development Framework⁷ (LDF). The Core Strategy covers the period from its adoption to 2026.
- 2.6.2 Air quality is cited within Policy CS10 (An Effective and Sustainable Transport Network), which states, '...The Council will continue to alongside other Greater Manchester Boroughs on implementing Air Quality Management Plans to facilitate improvements in air quality along the Borough's major road corridors, where national and European targets on nitrogen dioxide emissions are currently not being met. The Council will promote the use of cleaner fuels amongst motorists and continue to use cleaner fuels for its own fleet of vehicles.... Modal shift from car to public transport, walking and cycling will also assist in an improvement in air quality....'

2.7 Greater Manchester Clean Air Plan

- 2.7.1 The proposed Greater Manchester Clean Air Plan⁸ (CAP) has been in development since 2018. The aim of the CAP is to bring nitrogen dioxide (NO₂) levels within legal limits in 'the shortest possible time.' This includes launching and operating a Greater Manchester-wide Class C Clean Air Zone (CAZ) which is expected to be introduced from spring 2022. The CAZ

3 Baseline air quality data

3.1 Local air quality monitoring data

3.1.1 Table 1 and Table 2 present the monitoring data from the continuous monitors and diffusion tube sites within the Davenport Green to Ardwick area. No exceedances of the hourly mean NO₂ standard were recorded at the continuous monitoring sites. No exceedances of the daily mean PM₁₀ standard were recorded at the Stockport Cheadle continuous monitoring site. Table 3 also presents the NO₂ measurements from the HS2 monitoring sites in this area.

4 Construction traffic data

- 4.1.1 Table 5 and Table 6 outlines the predicted flows for construction traffic on the highway network. The data presented are split into annual average daily traffic (AADT) and heavy duty vehicles (HDV) in the 'without the Proposed Scheme' and 'with the Proposed Scheme' scenarios.
- 4.1.2 The air quality assessment of construction traffic emissions has used traffic data based on an estimate of the average daily flows in the peak year during the construction period (2025 – 2037). The assessment assumes vehicle emission rates and background pollutant concentrations from year 2025 as a worst case.
- 4.1.3 Table 7 outlines the predicted flows of construction traffic on the site haul routes. The data are presented for the 'with the Proposed Scheme' scenario only split in heavy goods vehicles (HGV) and articulated dump trucks (ADT).
