


High Speed Rail (Crewe - Manchester) Supplementary Environmental Statement 2 and Additional Provision 2 (July 2023)

Guide to the SES2 and AP2

Why is the Bill being changed?

The proposed changes reflect our refinements to the design of the Western Leg and discussions with stakeholders.

A number of these changes require amendments to the Bill which are outside the original proposals. These changes make up AP2, which includes the following documents:

- a paper of amendments to the Bill;
- plans and sections that show the proposed amendments;
- a book of reference, identifying the owners and occupiers of affected land;
- a housing statement;
- · an estimate of expense; and
- the AP2 ES.

In January 2022 the
Government deposited a
Bill in Parliament seeking
powers to construct,
operate and maintain the
next phase of the High
Speed 2 (HS2) railway
known as Phase 2b Crewe
– Manchester (the 'Western
Leg'). Alongside it was an
Environmental Statement
('the main ES') setting out
the likely significant effects
of the proposals.

In July 2022 the Government deposited a further set of documents known as an Additional Provision (AP1), proposing changes to the Bill.

It included an environmental statement (the AP1 ES), which reported the likely significant environmental effects of the changes and our proposals to manage, reduce and avoid them.

AP1 was also accompanied by a Supplementary Environmental Statement (SES1), which reported the likely significant environmental effects of changes that were new, different, or removed, but are within the existing scope of the Bill.

The Government is now depositing a second Additional Provision (AP2) which proposes further changes to the Bill, along with an Environmental Statement (the AP2 ES) and a second Supplementary Environmental Statement (SES2).

What is the AP2 ES?

The AP2 ES reports on the significant environmental effects that the AP2 amendments are likely to have where these are new, different, or removed compared to those reported in the main ES as updated by SES1 and SES2. It also outlines the measures that are being proposed to avoid, reduce or manage these effects.

What is the SES2?

The SES2 reports on the likely significant environmental effects of changes that are new, different, or removed, but are within the existing scope of the Bill.

These changes include: new and updated environment baseline information (e.g. as a result of further surveys completed); changes to the design and construction assumptions; and corrections to the main ES and SES1 and AP1 ES.

The SES2 and AP2 ES are separate environmental statements but are in combined volumes so that they can be reviewed together.

Can I comment on SES2 and AP2 ES?

Yes. The Government is consulting on the SES2 and AP2 ES. The consultation will run until **11:45pm on 31 August 2023**.

Can I object to AP2?

Persons whose property or interests are specially or directly affected by the amendments to the Bill for which powers are sought under AP2 have the right to petition against AP2. If you are directly affected you will have received a notice, together with a letter and a guidance leaflet explaining what to do next.

The last date for depositing a petition against the proposals is **5pm** on **15 August 2023**.

How do I find the environmental information I need?

The SES2 and AP2 ES are made up of a number of documents that are publicly available.

Non-technical summary

This is a summary of the changes and amendments reported in the SES2 and AP2 ES, and of any new or different likely significant residual effects on the environment (i.e. effects which are likely to remain after mitigation measures are put in place) compared to those reported in the main ES, as updated by the SES1. AP1 amendments are taken into account where relevant. You may find this a useful place to start.

What is an AP?

An Additional Provision (AP) is a package of proposed amendments to a Bill.

APs are part of normal procedure for projects of this kind; a number of APs may be put forward on the Bill's journey through Parliament.

What are "existing powers and limits"?

The 'existing powers' are the powers to build and operate the railway and associated works, as sought in the original Bill or proposed to be amended by AP1. The 'existing limits' are the land they cover.

AP2 proposes changes to the Bill that are outside this original scope (e.g. where land outside existing limits if required).

Glossary of terms and list of abbreviations

This contains any new or different terms and abbreviations used throughout the SES2 and AP2 ES which are not already explained in the main ES or the SES1 and AP1 ES and a list of references used in the SES2 and AP2 ES.

Volume 1: Introduction and methodology

This introduces the changes in SES2 and the amendments that have resulted in the need to amend the Bill which are assessed in the AP2 ES. It also explains the environmental impact assessment process that has been applied.

Volume 2: Community Area (CA) reports and map books

Each of these reports focuses on a particular area along the route. Volume 2 describes:

- the changes included within SES2; and
- amendments within AP2 ES.

Volume 2 reports any significant environmental effects that are likely to arise, where these are new, different or removed from those reported in the main ES, as amended by the SES1. The AP1 amendments are taken into account where relevant.

They also set out the measures that are being proposed to avoid, prevent or reduce the effects.

There are also map books for each CA showing 'before' and 'after' details of the proposed changes and amendments.

Volume 3: Route-wide effects

This volume reports any likely significant route-wide effects, where these are new or different from those previously reported.

Volume 4: Off-route effects

This volume reports any new or different significant effects that are likely to arise, where these changes affect areas beyond the route corridor between Crewe and Manchester (e.g. Annandale depot), compared with those previously reported.

Volume 5: Technical appendices and map books

This volume comprises technical appendices which contain supporting information and environmental topic maps.

Structure of SES2 and AP2 ES

This guide includes a diagram showing the structure of SES2 and AP2 ES as well as the types of documents included within each volume (**see overleaf**).

Volume 2: Community Area reports

There are SES2 changes and AP2 amendments in the following community areas:

Structure of the High Speed Rail (Crewe - Manchester) SES2 and AP2 ES

Non-technical summary

Provides a summary, in non-technical language, of the Supplementary Environmental Statement 2 (SES2) (Part 1) and the Additional Provision Environmental Statement 2 (AP2 ES) (Part 2) and of any likely residual significant environmental effects which are new, removed or different compared to those reported in the main Environmental Statement (ES), and the SES1 or AP1 ES as relevant.

Glossary, abbreviations

Contains any terms and abbreviations used throughout the SES2 and AP2 ES, and provides all references cited in each of the volumes.

Volume 1: Introduction and methodology

Provides an introduction to the SES2 and AP2 ES and explains the Environmental Impact Assessment (EIA) process that has been applied. This volume introduces the supplementary environmental information and changes to the design and construction assumptions included within the SES2 and amendments within the AP2 ES.

Volume 3: Route-wide effects

Describes any new, removed or different likely significant environmental effects arising at a route-wide level from the supplementary environmental information, changes to the design and construction assumptions included within the SES2 (Part 1) and the amendments within the AP2 ES (Part 2) compared to those reported in the main ES, and the SES1 or AP1 ES as relevant.

Volume 4: Off-route effects

Describes any new, removed or different likely significant environmental effects arising at off-route locations from the supplementary environmental information, changes to the design and construction assumptions included in the SES2 (Part 1) and amendments within the AP2 ES (Part 2) compared to those reported in the main ES.

Volume 2: Community Area (CA) reports

Consists of six reports and their associated map books. These reports set out the supplementary environmental information, changes to the design and construction assumptions included within the SES2 (Part 1), amendments within the AP2 ES (Part 2) and any new, removed or different likely significant environmental effects arising from these changes and amendments in each community area compared to those reported in the main ES, and the SES1 or AP1 ES as relevant.
